## Option 1, Participate by Phone

If prompted for a participant ID, press #.

## Option 2

or Any Device with Web Access

- Use this link or type it into a browser window: <https://zoom.us/j/8976327748>
- Click **Launch Meeting**.
- The webpage will prompt: **Download Zoom or join from your browser.**
- We suggest you choose: **Join from Your Browser** if you don't have the Zoom application. No download or installation is required.
- A new webpage will prompt you to enter your name, and then **Join**. Make sure to check the "I'm not a robot" box.
- You will enter a waiting room, where the host will admit you to the meeting.
  - Computer audio:** Use the microphone icon to mute yourself (or unmute to speak).
  - Phone audio:** If your computer audio isn't working, call 1-301-715-8592 and enter meeting ID 897 632 7748 to hear the meeting.
  - Video:** It is unnecessary to use your personal video to join the meeting.
